4. FIRST AID MEASURES

Description of necessary first aid measures

- Inhalation** : Remove victim to fresh air and keep at rest in a position comfortable for breathing. 6. ACCIDENTAL RELEASE MEASURES

Methods and materials for containment and cleaning up

7. HANDLING AND STORAGE

Precautions for safe handling
